CECT CHEST AND PNS

PROTOCOL: CT SCANNING OF THE CHEST AND PNS WAS OBTAINED AFTER ADMINISTRATION OF INTRAVENOUS IODINATED CONTRAST. NO ADVERSE REACTIONS SEEN.

FINDINGS IN CHEST :

- *There are multiple diffuse discrete and confluent centrilobular nodules bilaterally predominantly in apicoposterior segment of upper lobes, lingular segment of LUL, posterobasal segment of bilateral lower lobes.*
- Rest of the bilateral lungs shows normal attenuation and broncho vascular markings.
- Trachea and major bronchi appear normal.
- Mediastinal vessels and cardiac chambers appear normal.
- *Few subcentimetric homogenously enhancing mediastinal lymph nodes seen in right paratracheal region, largest measuring ~ 6mm in SAD.*
- No pericardial or pleural effusion seen.
- Chest wall appear normal.

FINDINGS IN PNS:

- *There is soft tissue density and mucosal thickening in bilateral ethmoid, sphenoid and maxillary sinuses.*
- *Bilateral frontal sinuses are not pneumatized.*
- B/L nasal cavities are visualized and appear normal.
- B/L anterior clinoid processes are not pneumatized
- Crista galli is not pneumatized.
- Visualized bones appear normal.
